**INDIAN DONATIONS**  
*(funds remitted from Indian Source of Income)*

Donations to Sri Sathya Sai Central Trust are accepted for the purposes of :

- 1) Medical Relief 2) Education 3) Relief to Poor 4) General Public Utility

As regards donations for Medical Relief, the Govt. of India has withdrawn Section 35AC benefit under the Income Tax Act, 1961 to assesses having income from business from the Assessment Year 2018-19 i.e. Financial Year 2017-18. Henceforth, donations for Medical Relief from assesses having business income will be eligible only for 50% income tax exemption under Section 80G of the Income Tax Act, 1961. **However, donations for Medical Relief continue to be fully (100%) exempt u/s 80GGA(2)(bb) of the Income Tax Act, 1961 for assesses not having business income. This exemption is available for the Financial Years 2017-18 and 2018-19 (i.e. Assessment Years 2018-19 and 2019-20)**

Donations for other purposes i.e., Education, Relief to Poor (Narayana Seva) and General Public Utility are exempt u/s 80G of the Income Tax Act, 1961.

Donations can be sent in favour of '**Sri Sathya Sai Central Trust**' by cheque / demand draft drawn on any Bank in India with a covering letter mentioning :

- (a) name and complete address of the donor with the postal pin-code number;  
(b) purpose of donation;  
(c) PAN Card Number; and  
(d) contact details - mobile / telephone number as well as email-id.
